

NASS PHASED ROLL-OUT

1.1 This Annex is intended as general guidance to help local authorities identify who is eligible for support under the Regulations. A list of local authorities in each region follows the table.

1.2 NASS has rolled out its support arrangements as follows:

3 April 2000	Asylum seekers who applied for asylum on arrival (port applicants) on or after 3 April 2000
17 April 2000	In-country asylum seekers living in Kent or Medway who applied for asylum on or after 17 April 2000. Port applicants living in Kent or Medway who were in receipt of social security benefits and have had their asylum application recorded as refused (disbenefited cases) on or after 17 April 2000
24 July 2000	In-country asylum seekers living in London who applied for asylum on or after 24 July 2000
31 July 2000	In-country asylum seekers who applied for asylum on or after 31 July 2000 and live in the North East, Yorkshire/Humberside, or Wales
14 August 2000	In-country asylum seekers who applied for asylum on or after 14 August and live in North West, East Midlands, Eastern, South West or South Central
29 August 2000	In-country asylum seekers who applied for asylum on or after 29 August and live in West Midlands and Sussex.
25 September	Port applicants living in England and Wales who were in receipt of social security benefits and have had their asylum application recorded as refused (disbenefited cases) on or after 25 September 2000.
